Dear Parents and Carers

Strike action by members of the National Education Union (NEU)

The NEU has voted to strike over pay and the next strike days are scheduled for **Wednesday**, **5 July** and **Friday**, **7 July 2023**. This letter concerns our plans for these two days.

Under current legislation, the NEU is only required to reveal how *many* members are employed at the School and employees are not required to tell their employer whether they intend to strike. Schools do not retain information on union membership, and the NEU has seen an increase in membership since the start of the action. This means it remains difficult to predict accurately where the staff absences may occur. There are also restrictions on what can be asked of staff participating in the action and what can be asked of the staff that remain, which further complicates planning.

A risk assessment has been conducted in light of these potential absences to determine whether and to what extent the School can open to pupils.

On **Wednesday, 5 July** pupils in **Years 7, 10,** and **12** will be accommodated on site, as will the **vulnerable pupils** and the **children of critical workers** cohorts; **all other pupils** will be taught remotely.

On **Friday, 7 July** pupils in **Years 8, 9,** and **12** will be accommodated on site, as will the **vulnerable pupils** and the **children of critical workers** cohorts; **all other pupils** will be taught remotely.

On the days there are **on site**, pupils will be organised as follows:

- Years 7 to 10 will be taught their timetabled lessons in their timetabled classrooms. Work will be organised in advance should any of the lessons need to be covered.
- Year 12 will be taught their timetabled lessons in their normal classrooms. Students will be guided to the work to be completed in the event that their teacher is not available.

Those **not** in **school** will be provided with <u>remote teaching</u> via <u>Microsoft Teams</u>.

- Vulnerable pupils and the children of critical workers who attend school will be supervised to access
 the remote learning on site via desktop computers in computer rooms. Please can these pupils bring
 headphones with them to plug into the school computers.
- Pupils should log into Teams before the scheduled start of the lesson and staff will invite them in.
 Please let us know if you anticipate any IT issues with your son joining lessons remotely via helpdesk@ermysteds.uk and we will see if anything can be done to help.
- Cover work will be collated beforehand by members of the leadership team and placed on Class
 Charts to cater for any staff absences on the day. Please note that the cover work may not relate to
 the scheduled lesson, but care will be taken to ensure this work is applicable to all pupils in the year
 group.
- Staff will be asked to deliver remote lessons of 50 minutes in length (rather than the standard 60 minute lessons) to ensure a break from screens of at least 10 minutes between lessons for both staff and pupils.

Safeguarding

Vulnerable pupils and children of critical workers

The Pastoral Team will contact the vulnerable pupils and children of critical workers (see Annex B on page 22, here¹, for the relevant definitions) who attended school on the last strike day and invite them in again.

The Refectory will be open and providing food and drink for purchase at Break and lunchtime as normal.
